Your attention is invited to Section 82(5) of Maharashtra Universities Act. 1994, which is given below:-

"(5) Out of the applications recommended by the University, the State Government may grant permission to such institutions as it may consider right and proper in it absolute discretion, taking into account the State Government's budgetary resources. The suitability of the management's seeking permission to open new institutions and the State level priorities with regard to location of institutions of higher learning:

Provided however, that in exceptional cases and for the reasons to be recorded in writing any application not recommended by the University may be approved by the State Government for starting a new college or Institution of higher learning;

(Provided further, that, from the academic year 2001-2002 such permission from the State Government shall be communicated to the University on or before 15th July of the year in which the new college is proposed to be started. Permission's received thereafter shall be given effect by the University only in the subsequent academic year."

In this connection, you are hereby requested not to admit the students in your proposed new College/Institute for the above mentioned courses without the prior permission from the aforesaid authorities as well as NCTE, Bhopal, B.C.L., New Delhi and University of Mumbai, though proposal is recommended.

Further. I am to invite your attention on the following points :-

- The permission given by the Government will be communicated to the Management, as soon as it is received by the University.
- If no reply has been received from the Government on or before 15th July, 2009, it will be presumed that the permission has not been granted by the Government for opening of your proposed new College/Institute for the academic year 2009-2010.
- If the permission is received from the Government after 15/07/2009, the said permission will be considered for the subsequent year i.e. 2010-2011 for opening of your proposed new college, as per the Maharashtra Universities Act, 1994.
- 4. If reply from the Government is not received till the end of <u>first</u> term of the academic year 2009-2010, then it will be presumed that the Government has not granted permission for opening of your proposed new college and one third amount will be refunded as per the Ordinance of the University.
- Further, in any case the aforesaid application together with fees will not be considered for the next academic year 2009-2010 and thereafter you have to make a fresh application alongwith the requisite fees for the next academic year i.e. 2010-2011 if you desire so.


